1. Candidates will be provisionally allowed to appear in the ETEA screening test. However detailed scrutiny will be carried out by the appointing authority and if any candidate is found ineligible in any respect at any stage or in the recruitment process, he/she will be disqualified by the appointing authority.
2. Interview calls letter will be issued to short listed candidates only.
3. Short listing will be based on the screening test conduct by ETEA.
4. Candidates shall be eligible in all respect by the last date of receipt of applications.
5. Incomplete applications and applications received after last dates will not be entertained.
6. Relaxation of age will be admissible as per existing government rules.
7. The Candidates working in Government/ Semi Government should apply through proper channel.
8. Competent authority reversed the right to cancel / reject any application with assigning reason.
09. Minority quota will be observed as per Government rules.
10. Error/omission in number of posts are subject to rectification.
11. No TA/DA is admissible for the test/interview.

2. After successful submission of online application, a prescribed online deposited slip (having token number, project code & candidates personal information) will be generated.
3. Take a printout of the generated deposit slip & deposit the prescribed test fee (non-refundable) in any Branch of HBL, UBL Omni Agent, Easy Paisa app or Agent.

4. After successful fee submission, please keep the original deposit slip (Candidates copy) having bank stamp with yourself and do not share it with anyone else.
5. Please do not send any documents to ETEA, provision of documents/testimonials to ETEA office.
6. Copies of testimonials documents will however, be provided by the candidates who qualify the screening test, as and when required by ETEA or the appointing authority for security purpose.
7. Availability of online application form on [www.etea.edu.pk](http://www.etea.edu.pk) on 01/10/2022.
8. Last date for submission of online application is 20/10/2022.
9. Candidates will be informed through SMS by ETEA to download and print their Roll No. slips from ETEA website [www.etea.edu.pk](http://www.etea.edu.pk). Candidates are directed to do not give ported/converted mobile number.
10. Test date, time and venue will be mentioned on Roll No. Slips.
11. No separate call letter will be issued to candidates for screening test through postal/courier means.
12. Candidates will be informed by ETEA through SMS for physical test, screening test.

That candidate who qualify physical test, screening test, of ETEA the successful candidates will be informed through SMS for final interview in which date, time venue will be mentioned and separate letter will be issued through postal or courier.

2. Read the instructions thoroughly before filling online applications form.
3. ETEA shall verify deposit fee at any stage. If your payment is not verified, your candidature shall be rejected.
