As approved by the competent authority, the process of A-I Exam 2021 is to

be carried out as per below schedule:-

1	Online Application Forms should be available at www.etea.edu.pk	13.04.2021
2	Last date for submission of ETEA Form with OASI/OHC	28.04.2021
3	Last date for OASI/OHCs for submission of forms to ETEA office.	04.05.2021

2. HOW TO APPLY ONLINE FOR A-I EXAM: 2021

- Eligible candidates (Constables) should visit www.etea.edu.pk and apply online for A-I Exam: 2021.
- After successful submission of online application, take a printout of the PDF generated Application form along with a prescribed UBL online deposit slip (having token number, Project code & candidates personal information) & deposit Rs. 500/- as test fee (non refundable) in any branch of UBL or UBL OMNI Shop on that prescribed printed deposit slip of UBL.
- Submit the printed application form along with UBL bank receipt (original candidate copy), 01 recent passport size photo and copy of CNIC & Service Card to the respective OASI/OHC office.
- OASI/OHC will countersign/ stamp all the submitted forms after checking/ verifying candidate's eligibility.

3. OTHER IMPORTANT INSTRUCTIONS:-

- Please keep your documents and passport size scanned picture (soft copy) with you at the time of online applies.
- Read the instructions thoroughly before filling the online application form.
- ETEA shall verify deposited fee at any stage. If your payment is not verified, your candidature shall be rejected.
- Fee deposited on someone else CNIC shall not be verified.
- OASIs/OHCs are required to submit the collected application forms latest by 04.05.2021 to ETEA office, i.e. ETEA will not accept any application form after 04.05.2021.


